Conference significance

Green infrastructure is a term of wide comprehension including green spaces and water basins situated within “grey infrastructure” of the urban zones.

Green infrastructure includes green areas of planting and corridors connected to more wide landscapes outside the city. These areas and corridors like city parks, gardens, street trees, roof gardens, green walls, rivers and ponds are situated in living, commercial and trade zones.

The main reason of the interest to the green infrastructure in the world is the intent to make cities more favorable and attractive place to live in. Several researches, historical evidences and immediate experience demonstrate the importance of the green infrastructure in improving of the urban life conditions.

Well developed and integrated green infrastructure improves the life conditions, attracts people, gives impulse to trade, increase the real estate value, reduce the crime rates and unite people – the better the place - the better are the people living in it.

Conference objects

- creation of a large discussion platform to organize the exchange of information and experience about the green infrastructure as a key factor for favorable conditions of everyday life in cities;
- assistance to the practical realization of “green” infrastructure projects;
- assistance to the practical realization of “green” urban policy.

Conference main activities

The conference includes plenary meeting and special sessions, master class, and also final meeting to summarize the Conference results.

Special sessions

The Conference will highlight the following subjects:

- “Ecological and urban development of city spaces and parks”.
- “Green space as an architectural and ecological factor of landscape organization and aesthetics of the urban space”.
- “Ecology of big cities and landscaping industry: integration methods”.
- “Functional landscaping design, reconstruction and reservation of parks”.
- “Development of the eco-cities system and modernization of the green infrastructure”.
- “Innovations of green architecture as a factor of life quality in the big cities”.
- “Architectural ecology: challenges, special characteristics, planning”.

- “Organization of greening system of the urban environment”.
- “Landscaping system as an element of ecological structure and environment-forming factor of the city’s climate”.
- “Reconstruction and renewal of the lost natural and landscaped territories of the urban environment”.
- “Role of the education in the landscaping of the cities”.
- “Urban forests in the heart of city centers”.
- “Design of the “green” future”.

Draft plan of plenary meeting and sessions

The Conference program to be developed and approved on the basis of Conference participants’ proposals.

Procedure of plenary meeting: reports of foreign speakers – up to 40 minutes, reports of Russian speakers – up to 15 minutes, speaking – up to 10 minutes.

Procedure of sessions: reports – up to 10 minutes, speaking – up to 5 minutes.

Sessions to be carried out simultaneously (up to 4 sessions).

List of sessions participants will be prepared on the basis of application forms received.

Special working teams directed by session leaders to be formed to carry out the conference sessions.

The sessions object is to discuss the relative matter, exchange of opinions and make recommendations.

The following tasks will be performed during the sessions:

- revealing of key problems of the discussed matter;
- exchange of information about the work experience;
- discussing the ways to resolve the problems;
- working on measures which should be included into Conference Recommendations.
